

2020 WISCONSIN QUILT SHOP HOP OFFICIAL RULES

These are the Official Rules for the 2020 Wisconsin Quilt Shop Hop (“Promotion”).

**NO PURCHASE OR TRANSACTION IS NECESSARY TO ENTER OR WIN.
MAKING A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING.
THIS PROMOTION IS VOID WHERE PROHIBITED BY LAW.**

- 1. Sponsor:** This Promotion is being coordinated by Wisconsin Quilt Shop Hop Inc. 214 S Barstow St, Eau Claire, WI. 54701 (“Shop Hop”).
- 2. Terms and Conditions:** By participating in the Promotion, you fully and unconditionally agree to and accept these Official Rules and the decisions of the Shop Hop, which are final and binding in all matters related to the Promotion. Your ability to receive one or more prizes is contingent upon all the requirements set forth herein.
- 3. Eligibility:** The Promotion is open only to legal residents of the United States, who, at the time of entering the Promotion are eighteen years of age or older. All entrants must be natural persons. No entries from business entities will be accepted. Employees and volunteers of the Shop Hop, and their immediate family members (spouse, parents, siblings and children) and/or those living in same household are not eligible to enter the Promotion. **THIS PROMOTION IS VOID IN RHODE ISLAND, FLORIDA, NEW YORK, AND WHERE PROHIBITED BY LAW, RULE, REGULATION OR ORDINANCE.**
- 4. Promotion Period:** The Promotion begins on June 5, 2020 at 9:30 a.m. Central Standard Time and ends at 4:00 p.m. on July 25, 2020 (the “Promotion Period”). Entries submitted before or after the Promotion Period will be disqualified.
- 5. How to Enter:** Eligible participants can get a free official qualifying passport at any participating shop as published in the 2020 Wisconsin Quilt Shop Hop publication, during the Promotion Period. No purchase is necessary to enter or win. During the Promotion Period, you must visit participating shops and have your passport stamped. You must be present to have your passport stamped and no purchase is necessary. During the Promotion Period you enter the Promotion by submitting an official qualifying passport requiring your complete name, address, phone number, and e-mail address at any participating shop.

Grand Prize level drawing requires you visit all participating shops statewide (60).

2nd Place Prize level drawing requires you visit all participating shops statewide (60).

Section Prize level drawing requires you visit all shops in a section.

- 6. Prize Drawing:** Winners will be selected by random drawing held on or about August 10, 2020 from all eligible entries received. Your odds of winning depend upon the number of entries received. The Shop Hop will make efforts to contact the winners on or before August 17, 2020 via telephone, e-mail or mail service. 9. Responsibility for Prize. If you win one or more Prizes as part of this Promotion, you understand and agree that you are solely responsible for the use, care and maintenance of the Prize(s), including (without limitation) any and all insurance requirements and liability for use.

10. Publicity: Acceptance of the Prize constitutes consent for the Shop Hop to use your name and likeness for editorial, advertising and publicity purposes without additional compensation, except where expressly prohibited by law. You agree to enter into any additional releases requested by the Shop Hop if you win one or more Prizes.

- 11. Social Media:** The Promotion may be advertised or administered through social media platforms, such as Facebook and Twitter (“Social Media”). Any information you provide for the Promotion is being provided to the Shop Hop rather than Facebook or any other Social Media platform. You fully release Facebook and all other Social Media from all claims, losses and harm that you may allege or incur relating to this Promotion.
- 12. General Conditions.** If the operation, security or administration of the Promotion is impaired in any way for any reason, or if the Promotion is unable to be run for any reason, as determined by Sponsor in its sole discretion, the Sponsor may suspend, cancel or terminate the Promotion. The Sponsor reserves the right to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion, or acts in violation of these Official Rules, or acts in a disruptive or unsportsmanlike manner.
- 13. Other Requirements.** The winner may, at the Shop Hop’s discretion, be required to sign and return a declaration of eligibility, additional release of liability, and, where lawful, an additional publicity consent agreement. If a selected winner cannot be contacted, is ineligible, fails to claim a prize, or fails to return the completed and executed declaration and releases as required, the prize will be forfeited and awarded to an alternate winner.

connection with the Promotion. Entries become the property of Shop Hop and will not be acknowledged or returned.

17. Disqualification. Shop Hop reserves the right to disqualify any person tampering with the entry process, the operation of the Shop Hop website, or who is otherwise in violation of these Official Rules or any laws.

18. Disputes. Except where prohibited, all disputes relating to the Promotion and/or any Prize shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court in the State of Wisconsin. By entering the Promotion, you agree to the extent possible, to venue of the courts in Wisconsin.
